

## **CORRIGENDUM IN RESPECT OF THE TENDER FOR THE PROCUREMENT OF L2 & L3 SWITCHES**

A tender for the above has already been floated on the website of NIXI. In this connection, It is stated that the a few changes have already been made in the tender at suitable places on the request of parties. But, still we are receiving calls from the parties for clarifications. is, therefore, reiterated once again for the knowledge of the prospective tenderers that:

- 1. Delivery Time will be 4 weeks.**
- 2. The payments terms will be as under:**
  - a. 30% at the time of delivery.**
  - b. 40% after the successful installation and commissioning (*If NIXI location is not finalized and installation remains pending then NIXI may release after 60 days*).**
  - c. 20% after 3 months of successful operations. (If installation pending then NIXI may release after 90 days).**
  - d. 10% after the completion of 1-year warranty.**

**[In case the party gives the PBG of 10% against point “d” as above then the entire payment will be released after 3 months of successful operations].**
- 3. The PBG of 10% in lieu of releasing the balance payment of 10% will be for 1 year only. However, the Security deposit (in general) in form of PBG will be 10% for 3 years of warranty.**
- 4. The technical specifications pertaining to Deep Buffer/Natting/NMS are deleted.**
- 5. The nature of SFP modules will be Long Range (LR) i.e. 10 kilometres.**
- 6. Only fibre optics is recommended.**
- 7. The clauses pertaining to loop detection and CRC (Support storm control) will not be deleted.**
- 8. The bifurcation of Egress and Ingress cannot be given.**
- 9. The spare part availability will be 5 years if there is end of sale from OEM side.**
- 10. The warranty should be (3 Years) and AMC (2 years) as per vendor recommendation.**
- 11. In case of split of orders among different vendors for speedy delivery, it should be 6:4 for 2 vendors and 5:3:2 for 3 vendors.**
- 12. The installation and commissioning shall be the responsibility of the vendors. In case the vendor asks separate cost for installation and commissioning then NIXI can approve only Rs.35K per switch including installation, commissioning & travel of vendor.**

**13. In case of any hardware failure of the switch during installation Vendor need to raise RMA and send the parts and replacement would be the responsibility of Vendor in switch installed location.**

**14. The response time for remote areas can be increased from 3 hours to 9 hours where air connectivity is not available but for metropolitan and tier 1 cities it should be 3 hours where air connectivity is present.**

**15. Exact location of delivery will be intimated while providing PO. Whereas if location is not decided then vendor may deliver in the NIXI HQ.**

**16. The Training clause as decided earlier will not change.**

**It is further informed that:**

**--Certification criteria EAL2/EAL2+/EAL3+/NDPP/UL/IEC or higher are accepted.**

**These are the parameters, which have been duly approved by the CEO.**
