

**Engagement of a Technical Expert as Consultant on
Retainer ship Contract basis**

The National Internet Exchange of India (NIXI) is a “not for profit” Organization under section 8 of the Companies Act 2013, and was registered on 19th June, 2003. NIXI was set up for peering of ISPs among themselves for the purpose of routing the domestic traffic within the country, instead of taking it all the way to US/Abroad, thereby resulting in better quality of service (reduced latency) and reduced bandwidth charges for ISPs by saving on International Bandwidth. NIXI is managed and operated on a Neutral basis, in line with the best practices for such initiatives globally.

2. The National Internet Exchange of India (NIXI) invites application from interested and eligible experienced candidates for engagement as a .IN Registry (Technical Service Provider) Expert (hereafter called Consultant) on retainer ship Contract basis.

3. The eligibility criteria: -

i. Bachelor Degree in Electronics & Communication Engineering.

Work Experience: Minimum 10 years of relevant professional experience in handling .IN Registry (TSP) and working in at least three domain registries and in multi-stakeholder orgs. Like ICANN.

ii. Additional Skills: Comprehensive understanding of Internet Governance.

Other Requirements

1. Communication Skills: Strong verbal and written communication skills for reporting representation and stakeholder engagement.

2. Analytical Skills: Strong analytical and problem

4. Scope of Work:

- The incumbent will be responsible, for compliances matter related to .IN Registry as Technical Service Provider.
- Having experience in leading at least one registry transition project and managing cross-functional and geographically dispersed teams.
- Managing Regulatory Advisory on .IN Registry.
- He will be assigned any other related activity as may be deemed fit by management
- Contribution to significant engagements such as Universal Acceptance and Internet Governance.

5. Monthly Remuneration:

The selected incumbent will be entitled for a consolidated monthly retainer ship fee of **Rs. 1, 00,000- 1, 50,000/- (all inclusive)**. The retainer ship fee will be payable at the end of each calendar month, upon receiving the invoice from the Consultant and submission of satisfactory performance report by the Competent Authority in NIXI

The TDS (Tax Deduction at Source) will be recovered by NIXI as per the Income Tax Act 1961, for which Consultant will provide a copy of the PAN card.

6. The Consultant will also be entitled for TA/DA as applicable to the Executive level as per HR Policy of NIXI for the any official visit.

7. Upon selection, the initial contract of the Consultant shall be for one year, extendable by two years at the discretion of the Competent Authority with increase in consultancy fee @ 5 percent every year. The contact between the Consultant and NIXI can be terminated by either party by giving a notice of one month.
